BY-LAW NO. 26-83

Being a By-Law to establish a Community Recreation Centre at
Coe Hill School, Hamlet of Coe Hill ..

WHEREAS THE Community Recreation Centres Act, 1974, provides in Section 2(1) that the Council of any municipality may, by By-Law, provide for the establishment of one or more community recreation centres in accordance with the said Act and may acquire by purchase, lease or otherwise real and personal property for the purpose;

AND WHEREAS the Corporation of the Township of Wollaston is desirous of establishing a community recreation centre at the Coe Hill School in the Township of Wollaston ..

Therefore, the Council of the Corporation of the Township of Wollaston enacts as follows:

1. That a community recreation centre be defined as a Community Hall-Gymnasium be established and operated by the Corporation pursuant to the provisions of the Community Recreations Centres Act, 1974.
2. That the said Community recreation centre be administered by a committee of management appointed pursuant to the provisions of the Community Recreation Centres Act and Regulations thereunder. The committee shall be appointed annually by Council.
3. That the Reeve and the Clerk be and they are hereby authorized to execute all documents necessary to give effect to the foregoing.
