



TOWNSHIP OF WOLLASTON

BY-LAW NO. 14-90

Being a By-Law to appoint a Road Superintendent
in the Township of Wollaston in the County of Hastings.

WHEREAS it is desirable that the laying out and supervision of all of all work and expenditure upon improvement and maintenance of roads within the exclusive jurisdiction of this Council should be under the supervision of a Road Superintendent, acting under its direction.

AND WHEREAS it is the desire of this Council to take advantage of The Public Transportation and Highway Improvement Act and to receive the Government grant as provided in the said Act.

BE IT THEREFORE ENACTED by the Council of the municipal corporation of the Township of Wollaston and it is hereby enacted.

1. THAT Buddy Post of Coe Hill, Ontario, is appointed Road Superintendent in the said Township to act as aforesaid in accordance with the provisions of the said Act from 30 days of April, 1990 and during the pleasure of the said Council.
2. THAT it shall be the duty of the superintendent to lay out and supervise all work and expenditure on roads within the exclusive jurisdiction of this Township Council in accordance with the provision of The Public Transportation and Highway Improvement Act.
3. THAT all by-laws or parts thereof and all and any regulations of said Council contrary hereto or inconsistent herewith, be and the same are hereby repealed.
4. THAT one certified copy of this by-law be forwarded by the Clerk without delay to the District Office of the Ministry of Transportation.
