THE CORPORATION OF THE TOWNSHIP OF WOLLASTON

BY-LAW NO. 13-95

being a By-Law to accept title from Lawrence Hiltz and Sharon Hiltz of Part of Lot 15, Concession 8, in the Township of Wollaston, in the County of Hastings, being PART 3, PLAN 21R-16845 and further authorizing a Transfer from this Municipality to James Hiltz and June Hiltz for Part of Lot 15, Concession 8, being PART 1 on said PLAN 21R-16845 together with a Right-of-Way in, over, along and upon said PART 3 and further to authorize a Transfer from this Municipality to Lawrence Hiltz and Sharon Hiltz for Parts of Lot 15, Concession 8, being PARTS 3 & 4, PLAN 21R-16845, subject to the aforesaid Right-of-Way over said Part 3.

WHEREAS James Hiltz and June Hiltz have occupied their residence on PART 1, PLAN 21R-16845, for many years and have obtained access thereto over PARTS 2 & 3 on said PLAN 21R-16845;

AND WHEREAS Council of this Municipality deems it expedient to provide the said James Hiltz and June Hiltz with evidence of their title in the form of a Transfer;

AND WHEREAS Lawrence Hiltz and Sharon Hiltz have for many years obtained access to their property over Township lands being PARTS 3 & 4, according to said PLAN 21R-16845;

AND WHEREAS Council of this Municipality deems it expedient to provide them with a Grant of Right-of-Way;

NOW THEREFORE the Council of the Corporation of the Township of Wollaston enacts as follows:

1. This Township accepts title by way of a Transfer from Lawrence Hiltz and Sharon Hiltz for Part of Lot 15, Concession 8, being PART 3, PLAN 21R-16845, in the Township of Wollaston.
2. The Reeve and Clerk of this Municipality are hereby authorized on behalf of this Municipality to execute a Transfer in favour of James Hiltz and June Hiltz conveying Part of Lot 15, Concession 8, being PART 1, on said PLAN 21R-16845, together with Rights-of-Way in, over, along and upon PARTS 2 & 3, on said PLAN 21R-16845, in the Township of Wollaston, in the County of Hastings.
3. The Reeve and Clerk of this Municipality are hereby authorized on behalf of this Municipality to execute a Transfer in favour of the said Lawrence Hiltz and Sharon Hiltz for Parts of Lot 15, Concession 8, being PARTS 3 & 4, on said PLAN 21R-16845, subject to a Right-of-Way over said PART 3, in the Township of Wollaston, in the County of Hastings.
