THE CORPORATION OF THE TOWNSHIP OF WOLLASTON

BY-LAW NO. 10-00

being a By-Law to authorize the Reeve and Clerk to execute a Transfer in favour of GARTH DAVID PASCOE to transfer Part Lot 32, Concession 9, being PART 1, Plan 21R-6690, in the Township of Wollaston, in the County of Hastings

WHEREAS this Municipality is the owner of Part Lot 32, Concession 9, being PART 1, Plan 21R-6690, in the Township of Wollaston, in the County of Hastings;

AND WHEREAS it is deemed by Council of this Municipality that the said lands as herein described are no longer required for municipal purposes;

AND WHEREAS this Municipality deems it desirable to transfer unto GARTH DAVID PASCOE the premises herein described.

NOW THEREFORE the Council of the Corporation of the Township of Wollaston ENACTS AS FOLLOWS:

1. The Reeve and Clerk of this Municipality are hereby authorized and empowered to execute a deed and to affix the seal of this Municipality thereto, conveying unto GARTH DAVID PASCOE part of Lot 32, Concession 9, being PART 1, Plan 21R-6690, in the Township of Wollaston, in the County of Hastings.
2. The Clerk is further authorized and directed to deliver the Deed to the said GARTH DAVID PASCOE upon payment by him to this Municipality of the purchase price in the amount of \$2,500.00, and registration of such Transfer shall be conclusive proof of payment of such consideration.
