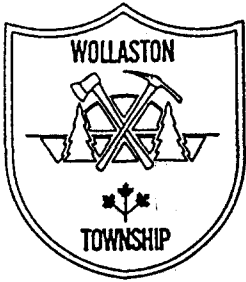




Dear Council Members:


