**The Corporation of the Township of Wollaston**

**By-Law No. 55-02**

BEING A BY-LAW TO AUTHORIZE THE CORPORATION OF THE TOWNSHIP OF WOLLASTON NATURAL PERSON POWERS.

WHEREAS Section 102, Municipal Act R.S.O. 1990, c. M.45 allows for general power for every Council to pass such by-laws and make regulations;

AND WHEREAS Section 8 (Natural Person Powers) and 11 (Spheres of Jurisdiction) of the Municipal Act 2001 provides authority to enable Municipalities to govern and to enhance ability to respond to municipal issues on a broader sphere;


AND WHEREAS Section 5 of the Municipal Act 2002 provides the powers of a Municipality shall be exercised by its Council;


AND WHEREAS NATURAL PERSON POWERS are the powers that are ancillary to other powers within the Act and allow Municipalities to take the necessary administration actions to exercise those powers under any statute.

NOW THEREFORE the Council of the Corporation of the Township of Wollaston enacts as follows:

- 1) THAT the current Council and succeeding Councils of the Corporation of the Township of Wollaston are hereby given authority under this by-law to exercise the powers of a natural person in accordance with this Municipal Act or any other Act; and
- 2) THAT this by-law shall come into force and take effect upon the passing thereof.

Read a first, second and third time and finally being passed this 17<sup>th</sup> day of December, 2002.
