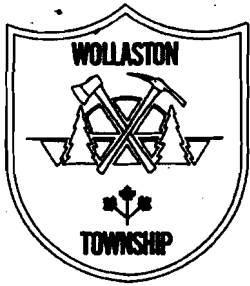

**The Corporation of the Township of Wollaston**

**By-Law 44-06**

BEING A BY-LAW to appoint a member of the Council to act in the place and instead of the Head of Council on any Board, Commission or other body of which the Head of Council is a member ex officio.

WHEREAS IT IS NECESSARY TO APPOINT A MEMBER OF Council to act from time to time in the place and instead of the Head of Council, when the Head of Council is absent from the Municipality, or absent through illness, or his or her office is vacant.

AND WHEREAS Part VI Section 242 of the Municipal Act 2001 states:  
"A Municipality may by by-law or resolution appoint a member of the Council to act in the place of the Head of Council when the Head of Council is absent or refuses to act or the office is vacant and while so acting such member has all of the powers and duties of the Head of Council".


NOW THEREFORE THE Council of the Township of Wollaston enacts as follows

That Brent Goodwin, Deputy Reeve is appointed to act instead of the Reeve Dan McCaw, on such occasions as stated in Sections 226 and 242 of the Municipal Act.

That this by-law repeals all previous by-laws and/or motions of Council pertaining to same.
