

All Management Staff must be aware of their duty to take every precaution reasonable in the circumstances for the protection of the Township of Wollaston workers, including those who perform work for the Township under contract.

Workers play a major role in the Health and Safety program by their participation on Joint Health & Safety Committees, reporting hazards, and the use of proper safety equipment when required.


