**By-Law No. 50-08**

A by-law to confirm the proceedings of Council

WHEREAS by Section 9 of the Municipal Act, Chapter M 45. R.S.O. 19 90, as amended, the powers of a municipal corporation are to be exercised by its Council;


AND WHEREAS by Section 101 of the Municipal Act, Chapter M 45, R.S.O 1990, as amended, the powers of every Council are to be exercised by by-law:


AND WHEREAS it is deemed expedient that the proceedings of the Council of the Corporation of the Township of Wollaston at its meeting be confirmed and adopted by by-law;

NOW THEREFORE the Council of the Township of Wollaston  
ENACTS AS FOLLOWS;

1. THAT the action of the Council of the Corporation of the Township of Wollaston in respect of each recommendation contained in the reports of the Committees, and each motion and resolution passed and other action taken by Council, at this meeting held on the August 20<sup>th</sup> 2008 is hereby adopted and confirmed as if all such proceedings were expressly embodied in this by-law.
2. THAT the Reeve and proper officials of the Corporation of the Township of Wollaston are hereby authorized and directed to do all the things necessary to give effect to the action of the Council referred to in all proceeding section hereof.
3. THAT the Reeve and Clerk be authorized and directed to execute all documents in that behalf and to affix thereto the seal of the Corporation of the Township of Wollaston.
