WHEREAS the Council of the Corporation of the Township of Wollaston deems it necessary to appoint members of various committees as required;


NOW THEREFORE THE Council of the Corporation of the Township of Wollaston enacts as follows;


The following people are hereby appointed to the Revitalization Committee. These members shall be appointed for the year 2009 and until the end of the Council term in 2010.
