**The Corporation of the Township of Wollaston**

**By-Law 21-10**

Being a By-Law to amend the Rural Economic Development Program.

**WHEREAS** *the Municipal Act*, S.O. 2001, c.25 and amendments a municipal power shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

**AND WHEREAS** The Ontario Ministry of Agriculture, Food and Rural Affairs entered into an Agreement dated October 1, 2007 with the Municipality of Hastings Highlands, the Town of Bancroft, the Township of Wollaston and the Community Futures Development Corporation of North & Central Hastings and South Algonquin under the Rural Economic Development Grant Program (reference number 4659);

**AND WHEREAS** the original agreement is to be amended extending the program from September 30, 2010, the original date the program was to end, to March 31, 2011;

**NOW THEREFORE** The Council of the Corporation of the Township of Wollaston does enact as follows:

1. **THAT** the Rural Economic Development Funding Agreement between the recipients and the Ontario Ministry of Agriculture, Food and Rural Affairs (file 4659) be and is hereby approved.
2. **THAT** Reeve and CAO be authorized to sign the amendment and affix the corporate seal.
3. **THAT** all other terms and conditions of the original agreement dated October 1, 2007 remain in effect.
4. **THAT** this By-Law shall become effective June 8, 2010.
