

The Corporation of the Township of Wollaston

By-Law 15-15

A By-Law of the Corporation of the Township of Wollaston to designate parts of highways under its jurisdiction as community safety zones.

WHEREAS pursuant to Section 214.1(1) of the *Highway Traffic Act*, R.S.O. 1990, Chapter H.8, as amended, the council of a municipality may by by-law designate a part of a highway under its jurisdiction as a community safety zone, if in the opinion of Council, public safety is of special concern on that part of the highway;

AND WHEREAS the Council of Corporation of the Township of Wollaston deems it expedient and necessary to implement such a by-law:

NOW THEREFORE the Council of the Corporation of the Township of Wollaston enacts as follows:

1.0 INTERPRETATION

1.1 Unless otherwise stated in this by-law, Subsection 1 of Section 1 of the Highway Traffic Act, R.S.O. 1990, Chapter H.8, as amended from time to time, is hereby adopted in this by-law for the purpose of definition and interpretation.

2.0 DEFINITION

2.1 "Council" means the Council of the Corporation of the Township of Wollaston.

2.2 "Highway" means a highway as defined in the Highway Traffic Act, R.S.O. 1990, Chapter H.8, as amended from time to time.

2.3 "Official Sign" means a sign approved by the Ministry of Transportation and placed or erected on a highway or elsewhere pursuant to the provisions of this by-law.

3.0 DESIGNATION:

3.1 Where official signs are erected or placed on highways in accordance with the regulations of the Highway Traffic Act, R.S.O. 1990, Chapter H.8, as amended from time to time. The highways set out in Column 1 are hereby designated as community safety zones on that portion of the highway described in Column 2 of Schedule "A" and shall be enforced during the period of times, days or months as set out in Column 3 to the said Schedule "A".

4.0 SEVERABILITY:

4.1 Should any section, sub section, clause, paragraph of this by-law including any part of Schedule "A" be declared by a court of competent jurisdiction to be ultra vires, invalid or illegal for any reason, the same shall not affect the validity of the by-law as a whole.


5.0 FORCE AND EFFECT:


