

**The Corporation of the Township of Wollaston**  
**By – Law 47-16**

**Being a by-law to amend Schedule “A” of Procedural by-law 01-13,  
Schedule of Regular Council Meetings 2017**

**WHEREAS** Section 238 (2) of the Municipal Act 2001, as amended, requires that every municipality and local board shall pass a procedure by-law for governing the calling, place and proceedings of meetings.

**AND WHEREAS** Section 238 (2) of the Municipal Act 2001, as amended, requires that the procedure by-law shall provide for public notice of meetings.

**NOW THEREFORE** the Council of the Corporation of the Township of Wollaston enacts as follows:

1. That Schedule “A” to By-Law 01-13 hereby be deleted and replace with Schedule “A” attached hereto;
2. That this By-law shall come into full force and effect on the date of final passage hereof at which time all By-laws and/or resolutions that are inconsistent with the provisions of this By-law and the same are hereby repealed or rescinded insofar as it is necessary to give effect to the provisions of this By-law.
